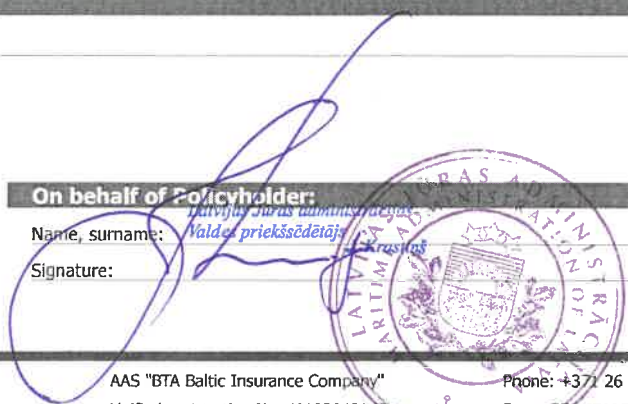

Special terms and conditions:

1. The Insurance agreement concluded in accordance with the tender for vessel insurance of VAS "Latvijas Jūras administrācija" (id.No JA 2019/02 MIE).
2. The following clauses and exclusions apply:
 - a) Classed or surveyed in accordance with statutory regulations;
 - b) Warranted vessel registered for the carriage of passengers and all recommendations complied with and registered passenger capacity not exceeded;
 - c) Warranted vessel insured for full insurable value for Hull & Machinery on conditions no less wide than Institute Total Loss Only Clauses including salvage and salvage charges;
 - d) Pursuant to the provisions of Clause 13.1, it is noted and agreed that the cover hereunder is extended to include claims for 4/4ths collision;
 - e) Including liability in respect of passengers but excluding liability to passengers in respect of aquatic or aerial activities or other water-sports undertaken from the insured vessel;
 - f) Excluding crew claims recoverable under the any compensation/state scheme, including all costs and expenses;
 - g) Excluding contractual obligations to continue crew wages and/or share of profits of vessel payments following sickness or injury;
 - h) Excluding liability to drivers whilst diving;
 - i) Excluding liability to cargo and property on board;
 - k) No P&I incidents for any vessel owned/operated by the Assured;
 - l) Cancelling Returns Only.
3. All disputes arising between the parties of the insurance contract shall be settled by means of negotiations. If mutual agreement cannot be reached, any dispute, disagreement or claim ensuing from the insurance contract that is related to it or its violation, termination or invalidity shall be resolved by the court of the Republic of Latvia in accordance with the procedure set forth in the effective regulatory enactments of the Republic of Latvia, unless another dispute settlement procedure is stipulated in the insurance contract by BTA and the Policyholder.
4. Deductible shall be 1 000.00 EUR for each insured event.

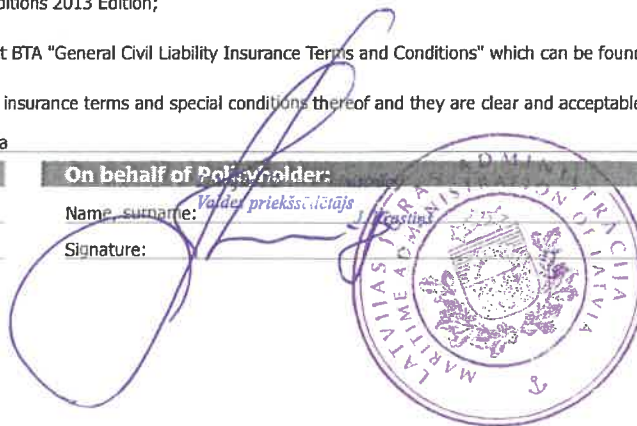
